A Place Called Home

While making a Ninth Step amends to his family, he learns that his father is a member of AA

I finished a four-week treatment program on my 31st birthday in June 1972. During the first week, three men from Group One in Kansas City, Mo. brought a meeting to us. I was impressed that three people would take time out of their lives to bring a meeting to a bunch of patients at the state hospital. They had what I wanted: clean clothes, money in their pockets, time in their life to visit with patients in a state hospital. I was impressed.

They said, "We know how you feel. We have been where you are. You do not know how we feel because you have not done what we have done or worked the program we try to work. But we are here to tell you that you can do what we have done. You can feel what we feel. The difference between us is we are going home to our nice clean beds and will get a good night's sleep. You are going to sleep in your hospital beds wondering if you will ever be able to change. You can change. You can have what we have."

My girlfriend picked me up at the hospital. I had a 30-day supply of antabuse and a prescription for an additional two months, as well as the advice of the director of the alcoholism treatment program. He had told me, "Those people who get better and stay better are those people who get active and stay active in the AA program." She drove me past the meeting place of Group One before we went to my rental place.

One of the first pieces of good advice I choose to ignore was to not make any major decisions in the first year of sobriety. My girlfriend and I decided to get married in August. Marriage preparations require a certain amount of ninth step work. My dad was a drunk of the periodic type. I needed to know where he was in his cycles to know how to handle him. My beloved and I went to visit him and my stepmother. Dad was not home when we arrived and I explained to my stepmother that I was in AA and it looked like I would have to attend meetings for the rest of my life.

She said, "You know your father is in the program."

"No." I said.

When dad arrived, he recalled his 65th birthday bash. He had lost his best worker and my stepmother had informed him that their marriage was over. He pleaded with her to go with him to an AA meeting. He had an address of one in Joplin, Mo. The address was a house in a residential area. My stepmother had her doubts. Dad did too but he knocked on the front door. The man who answered the door asked dad how long he had been carrying the clipping because they had not had a meeting there for years. Then he said, "Come on in. We'll have a meeting here today. Is that your wife in the car? Tell her to come on in. We'll put on a pot of coffee, call some folks, and we'll have a meeting."

Dad said that during the meeting he felt like he had come home. He was with folks who knew who he really was and loved him anyway. My father died sober in 1982 with over 13 years in the program.

I just celebrated both my 65th birthday and 34 years of sobriety with my friends at Group One, Kansas City. My wife and I are planning to celebrate our 34th anniversary in August. The program works. It really does. Welcome home.

To help get Big Books into a prison, she discovered a creative use of the Ninth Tradition

A fellow AA and I were at a state prison to carry the message to the inmates. Our meeting hadn't started yet, and the women were just arriving. We were short Big Books; I had brought only a few, and the prison had relocated their own small supply someplace inaccessible. A few of the women had their own. To my question, "Do you have a Big Book?" one of the women said, "No, I ordered one but it didn't come yet." Knowing the prison did not take orders for Big Books, I was surprised by her answer and asked from whom she ordered the book. Her response was from one of the AAs who bring in meetings. I bristled a little: placing book orders with an AA? No such thing. We're not organized at that level. As Tradition Nine notes, AA as a whole ought never be organized.

I attempted to explain to her that AA prison volunteers have no mechanism to accept individual book orders. But my explanation didn't make sense even to me, so I stopped. In my own ears, I sounded condescending and preachy. ("Never talk down to an alcoholic from any moral or spiritual hilltop ...") And anyway, the AA member who the attendee was referring to would undoubtedly bring the book next time (that volunteer's dedication to our AA prisoners is second to none).

The meeting began in our usual way—reading "How It Works" and the Traditions. As I listened to the readings, I heard Tradition Nine in a new light. "A.A., as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve." It dawned on me that I was directly responsible to these inmates: they're the ones I'm serving. Not my group, not the district, not the area. If serving them means taking Big Book "orders," then I can do that. It was the difference between the spirit of vested authority and the spirit of service—the two attitudes seemed miles apart.

I'm grateful for that woman's "Big Book order" and the opportunity to understand a little deeper Bill's purpose in Tradition Nine: The inmates and I can have a true fellowship.

Origins of AA

The origins of Alcoholics Anonymous can be traced to the Oxford Group, a religious movement popular in the United States

and Europe in the early 20th century. Members of the Oxford Group practiced a formula of self-improvement by performing self-inventory, admitting wrongs, making amends, using prayer and meditation, and carrying the message to others. In the early 1930s, a well-to-do Rhode Islander, Rowland H., visited the noted Swiss psychoanalyst Carl Jung for help with his alcoholism. Jung determined that Rowland's case was medically hopeless, and that he could only find relief through a vital spiritual experience. Jung directed him to the Oxford Group. Rowland later introduced fellow Vermonter Edwin ("Ebby") T. to the group, and the two men along with several others were finally able to keep from drinking by practicing the Oxford Group principles.

One of Ebby's schoolmate friends from Vermont, and a drinking buddy, was Bill W. Ebby sought out his old friend at his home at 182 Clinton Street in Brooklyn, New York, to carry the message of hope.

Bill W. had been a golden boy on Wall Street, enjoying success and power as a stockbroker, but his promising career had been ruined by continuous and chronic alcoholism. Now, approaching 39 years of age, he was learning that his problem was hopeless, progressive, and irreversible. He had sought medical treatment at Towns Hospital in Manhattan, but he was still drinking. Bill was, at first, unconvinced by Ebby's story of transformation and the claims of the Oxford Group. But in December 1934, after again landing in Towns hospital for treatment, Bill underwent a powerful spiritual experience unlike any he had ever known. His depression and despair were lifted, and he felt free and at peace. Bill stopped drinking, and worked the rest of his life to bring that freedom and peace to other alcoholics. The roots of Alcoholics Anonymous were planted.



Bill's Wife Remembers When He and She and the First A. A.s Were Very Young

As the wife of an early A.A., some of our experiences and my reactions to my husband's changed life may be interesting to other wives. Bill was an alcoholic, I believe, from the first drink he ever took, just a few months before our marriage. From then on, for seventeen years, I did everything I could think of to keep him away from liquor.

I will tell a little of our life before A.A. to help explain some of my later emotions. Bill and I had no children, so I soon felt that my job in life was to help Bill straighten himself out. As time went on, he earnestly tried to stop drinking. He was always very remorseful and perplexed the mornings-after. We would then resolve to lick this liquor situation together, launching off on some new tack.

As his drinking got worse, all decision and responsibility had to be taken by me. It was lucky that we were companionable, for gradually as our social contacts were broken we were thrust back on each other for company. In order to get away from alcohol over the week ends, I used to engineer some sort of outing, as we both loved the outdoors. If our pocketbook was flat, we might take the subway to the Dyckman Street ferry and hike along the Palisades to some scenic spot where we would nibble our sandwiches and gaze at the view. Or we might ferry to Staten Island and walk there; perhaps broiling a steak over a campfire. We have hired a rowboat at Yonkers and, using a bath towel as a sail, floated up the Hudson, to a spit of land near Nyack, where we camped and tried to sleep. We once went so far to get away from alcohol that we both gave up our jobs and took a whole year off. This we spent motorcycling and camping over half the United States.

These trips, although good for Bill's health, did nothing towards his permanent sobriety. In fact, his alcoholism grew steadily more serious. He lost job after job until I became entirely hopeless about him.

And then suddenly and finally Bill straightened out through the help of an old friend. At once I was convinced of his complete change and was of course extremely happy. Bill began to go to religious meetings and to work feverishly with alcoholics. I would go to meetings too and would try to share his newfound enthusiasms. He always had some drunk in tow and would work all night or get up in the middle of the night to go to the suburbs if one called him. We had drunks all over the house; sometimes as many as five lived there at one time.

One drunk committed suicide in the house after having sold about 700 dollars worth of our clothes and luggage. Another slid down the coal chute from the street to the cellar when we refused him the front door. Two others took to fighting, and one chased the other all around the house with a carving knife. The intended victim was saved by a third drunk, who delivered the knife-minded one a knockout blow. An alcoholic who was living in the basement was invited up for a pancake breakfast. After eating his share, he suddenly put on his hat and started out of the door remarking that he was going to Childs for PLENTY of pancakes.

Bill had found himself a job about this time; and it used to take him away from home a great deal and I was left with one or more alcoholics to look after. Once one of these boys lay in the vestibule all night and screamed invectives at me because I would not let him in. He was so loud the passers-by all stopped, looked and listened. Another time it was 4 a.m. before I succeeded in towing a drunk home. He was anxious to be at his job the next morning and we had gone out around midnight to look for a doctor, having been unable to get one to come to the house at that hour. I helped his shaky steps up and down stoops, lit his cigarettes for him and finally, when we could not rouse a doctor, held a drink to his lips in a bar. When I asked him how he then felt he said, "Well, a bird can't fly on one wing." After a few more drinks I managed to get him home, but he did not get to his job the next morning. I was once suddenly taken sick, and when my sister arrived to nurse me she found five men milling around in the living room, one of them muttering, "One woman can look after five drunks but five drunks cannot look after one woman."

Now to describe my reactions to it all. When Bill first sobered up I was terribly happy but soon, without my realizing it, I began to resent the fact that Bill and I never spent any time together any more. I stayed at home while he went off somewhere scouting up new drunks or working with old ones. My life's job of sobering up Bill with all its former responsibilities was suddenly taken away from me. I had not yet found anything to fill the void. And then there was the feeling of being on the outside of a very tight little clique of alcoholics into which no mere wife could possibly enter. I did not understand what was going on within myself until one Sunday, Bill asked me to go with him to a meeting. To my own surprise as well as his I burst forth with, "Damn all your meetings," and threw my shoe at him as hard as I could.

This bad display of temper woke me up. I realized that I had been wallowing in self pity; that Bill's change was simply miraculous; that his feverish activity with alcoholics was absolutely necessary to his sobriety; and that if I did not want to be left way behind I had better jump on the bandwagon, too!
