My name is Kim and I am an alcoholic. I am also the current Office Manager for the East Valley Intergroup's Central Office in Mesa AZ and have been employed here for the last 11 years.

The East Valley Intergroup covers the eastern portion of the Phoenix Valley and surrounding smaller towns. At the beginning of 2020 we were serving 128 registered groups with just over 600 meetings every week. Our local fellowship is very active in service and supportive of our local Central Office.

We had been operating our service center out of a very small office for several years and were rapidly outgrowing our space. 2019 had been our best financial year to date so the Steering Committee proposed a budget for 2020 that included upgrading our office space. The local fellowship approved overwhelmingly. We found a great place, signed a lease and planned our move for March/April 2020.

We had a Speaker/Dinner event coming up on March 14<sup>th</sup>. Plans for moving the office were moving forward on schedule. Things were going along fine until Friday, March 13. That was the day Arizona started to issue guidelines for operating during the COVID pandemic. Our annual anniversary dinner was scheduled for the next day. We decided to go ahead with the event as there were no mandates in place yet. Attendance was down a bit and we did take a loss on the event but at least it wasn't a huge one. Little did we know it would be the last in person event we would have for some time.

The move into the new office started to hit some bumps. A few volunteers went into self-quarantine to restrict their exposure. Others members stepped up to help out and we did get moved to our new location by April 1st and open for business. By then many meeting locations were shutting down. Groups were moving their meetings outside, online or suspending meeting entirely. About half of our live meetings were suspended at the height of the outbreak. The State of Arizona did mandate some businesses to be closed but A.A. was considered mental health care, an essential service and allowed to stay open.

The first two weeks in our new office we didn't have phone or internet service. The phone companies service departments were overwhelmed with a flood of new home offices being set up. We were able to transfer our 24-hour hotline to different volunteer's cell phones but for the second week of April the hotline was on my cell phone. While I wished I could have shared that job with others it was a labor of love manning the hotline that week. And the phone was ringing. It really kept me in touch with our local fellowship and their immediate concerns. People were calling for current meeting information and most were scared. They were afraid that Alcoholics Anonymous wouldn't be there to help them, they were afraid they would drink, many just felt alone. We also received calls from members wanting to know what they could do to help. I was blessed to have coordinated many connections and 12 step calls that week.

It was soon apparent that our top priority would be to provide updated information to our community. Our meeting directory was changing daily. It was impossible

to keep an accurate printed directory. Our website was quickly becoming our main link to the fellowship. We were updating it at least once a day with meeting changes. New local online meetings were popping up everywhere and we had to find a way to add this new type of meeting to our directory.

Office managers from Intergroups across the US and Canada started to meet weekly on Zoom to share information and experience. We were able to glean much useful information from other Intergroups who were farther along the technology learning curve. Some weeks I just needed to be able to connect with others facing the same challenges to preserve my sanity for a while longer.

Literature sales dropped off dramatically with the reduced foot traffic at the office but contributions started to go up. Groups were sending extra where they could. People attending online meetings where no basket was passed started to send in individual contributions. We added PayPal to our website to enable online contributions and members started to use that regularly too. Financially we only had to dip into our prudent reserve once and it was quickly replaced.

The most exciting thing to happen in the last year has been our increase in twelve step calls. They say no one gets here at the end of a winning streak and 2020 was far from a winner for most of us. We were getting calls from those barely nipped by the wringer to those who have lost everything, and all in between. Our idea of a 12<sup>th</sup> step call has been somewhat redefined. We don't think of "The Man on the Bed" situation as being the only 12<sup>th</sup> step opportunity. When a caller is new, returning or struggling in recovery we ask if they would like someone to give them a call. Many times they do and greatly benefit from a phone conversation, cup of coffee, a companion at their first meeting or a good old fashioned home visit from a couple of AAers. One drunk talking to another, the 12<sup>th</sup> step is alive and well.

The amount of support from so many has been overwhelming. I don't think I can adequately express my gratitude for it all. We were blessed with the most willing and capable Steering Committee to navigate the many changes. In hindsight HP had all the right people in place. From the local volunteers who are willing to do everything to the tech savvy members who have helped us learn all the new technology coming our way and the other managers sharing their tools and experience, thank you so very much. Thru it all there has been great support and I have never felt alone.

It has been a tough year and I wouldn't have asked for it but I do feel it has brought us together with new tools and connections that we might not have otherwise used. The ICOAA has a weekly Zoom meeting for Office Managers that I attend regularly now and it is a wealth of information and support. Zoom meetings are becoming common for service meetings making them more convenient and less costly to attend which increases accessibility and group participation. Groups and members are using their local service centers more as a clearing house of information and available service opportunities. We currently have 687 active meetings, 566 live and 121 online. Our live meetings are down by only 8% but we have gained 121 local online meetings. Our Intergroup is now more accessible than it has ever been.

And I have renewed confidence that Alcoholics Anonymous will be around for a long, long time.

### **Words From the Big Book**

Though our decision was a vital and crucial step, it could have little permanent effect unless at once followed by a strenuous effort to face, and to be rid of, the things in ourselves which had been blocking us. Our liquor was but a symptom. So we had to get down to causes and conditions. Therefore, we started upon a personal inventory. This was Step Four. A business which takes no regular inventory usually goes broke. Taking a commercial inventory is a fact-finding and a fact-facing process. It is an effort to discover the truth about the stock-intrade. One object is to disclose damaged or unsalable goods, to get rid of them promptly and without regret. If the owner of the business is to be successful, he cannot fool himself about values. We did exactly the same thing with our lives. We took stock honestly. First, we searched out the flaws in our make-up which caused our failure. Being convinced that self, manifested in various ways, was what had defeated us, we considered its common manifestations. Resentment is the "number one" offender. It destroys more alcoholics than anything else. From it stem all forms of spiritual disease, for we have been not only mentally and

physically ill, we have been spiritually sick. When the spiritual malady is overcome, we straighten out mentally and physically. In dealing with resentments, we set them on paper. We listed people, institutions or principles with whom we were angry. We asked ourselves why we were angry. In most cases it was found that our self-esteem, our pocketbooks, our ambitions, our personal relationships (including sex) were hurt or threatened. So we were sore. We were "burned up."

### **Getting Sober During COVID**

### A letter from a local member of the fellowship.

I woke up to my second chance at life June 26<sup>th</sup>, 2020. Amongst the Covid-19 pandemic, I had spent the last twelve years of my life drowning in my heavy alcoholism. The stay at home ordered issued state by state was my own comical cosmic situation. For I was not only an introvert, but a completely isolated alcoholic. My comfort to stay at home and drink continuously was what seemed to be the downward spiral I was free falling through, but now being fully detained at home by the pandemic order, I drank the last of the nails in my coffin. I could not function without two 750 bottles of whiskey, or a handle of it was never enough, and as frightened as my self and the public was expressing about this new virus, I had to leave the house, to always get more.

The last four months of my alcoholism seemed to be dowse with the anxiety and fear of this new world of Covid-19. I was quickly on the fast track of killing myself, nightly oblivion black outs, waking with the empty apologies, or whatever may have taken place in the night before, jumping up to grab a piece of toast as quickly as I could because the shakes had already begun, and I needed a drink.

The last two weeks of my drinking had turned any and all family away. I drained all accounts to feed my disease, nearly destroyed my marriage and every remaining ounce of myself. When I'd blackout I was angry and violent to myself and those around me. I managed to cause many of injury to myself in the nightly blackout pattern, and on my last night of drinking I had fallen down the stairs, cracked ribs, bruised and broken beyond belief. That's when I felt it. That pure anguish, I had hit rock bottom.

The next morning, I woke in complete and utter surrender as I admitted to myself and everyone around me, I needed help. After some calling around that day, I found a meeting of Alcoholics Anonymous. I limped in, head down, afraid, embarrassed, full within withdrawals. To my surprise, I was greeted with dozens of smiles, open arms, and a palpable loving presence that consumed me. That night I was giving a 24-hour chip and told, "You never have to drink again in this program, that can be your first and last 24-hour chip if you choose to stay". Leaving that night, I felt a sense of peace I haven't felt in over twelve years.

The first two weeks of my sobriety journey were a physical hell. I kept my nose in my big book, praying hour by hour it seemed, until I could experience the relief of the alcohol leaving my body. I went to at least one, most of the time two or three meetings a day. I had a strong inner knowing that if I didn't give 1000% of my heart and soul to the program, I would die. There is no if, this was a matter of life and death. The days started to show little blessings. I started to introduce myself, made myself a home group member,

then I received my one-month chip! What a pleasantly shocking moment,

never would I have thought I could go an hour without drinking, now I have made it thirty days! From here, I started opening myself up to other group members and began friendships. Within these friend ships it was made clear my next two right steps.

I found myself a sponsor, an incredible sponsor and began to work the steps honestly and thorough. Having the willingness to work these steps proved to be no easy feat, but I pushed through a lot of tears, pain, grief, remorse. In the fifth step I found such a healing I've only up until then had heard from other members sharing. Experiencing it though, was such a deep breath and a peace of "I'm going to be okay". The weight on my heart and soul from so many damaging years of trauma and addiction to alcohol seemed to be slowly lifting away, day by day. Having the healing of the combination of my higher power and working these steps one by one as it was suggested my first night, I was getting myself and my life back. Sixty days came and I felt as if I just finished a marathon. Putting in the spiritual work was exhausting, but oh so rewarding.

The promises became more apparent in my life, as I was able to mend my relationships, able to be present and a part of brought me such joy. Ninety days seemed to come so fast, as my healing gave me a true and our psychic change. I not only forgave myself, but was able to like and now love myself for the strong woman I am. I have become.

It is now December of 2020, and the world is still in chaos. The Covid-19 virus has taken many lives, destroyed many families, and the future seems uncertain. A few things are very certain though, by the grace of my higher power, and the fellowship and program of Alcoholics Anonymous, I am six months sober the day after Christmas. I am thriving in my sobriety, and recently have been able to provide service by chairing an evening meeting. I have multiple wonderful friendships, and an amazing life with my husband and family. I still take it one day at a time, and every day is a new blessing.

Alcoholics Anonymous saved my life. May all who read this story, have a blessed and sober holiday, and life! "Keep coming back".



## Central Office Manager's Report March 19, 2020

In February we received 459 requests for information and assistance last month. Of those 126 calls were for meeting info, 121 were office visitors and 15 resulted in a 12-step call. Our website stayed busy too. It had 29,482 visits in the last 30 days. Our Google listing also receives steady traffic. Our Google totals for February were 6,731 views. Of those 446 went to our website, 52 requested

directions and 43 gave us a call. We are seeing a few events popping up in the future both live and virtual. Keep checking the Events page at aamesaaz.org.

We have been in our new location for a year now, and what a crazy year it has been. Check out the April edition of the No Booze News for EVI 2020 story. It is a little piece I wrote to commemorate all the changes and challenges of the last year.

### A letter from an Inmate

### Keith N. Inmate @ AZDOC Florence

We are blessed and privilege to reflect upon Step Three: "We made a decision to turn our will and our lives over to the care of God as we understand Him." I can't count how many times over and over I turned my will over to destructive powers.

Power is defined as: "one that has control or authority." This may be a person, place, or thing! I found shelter in destructive powers for more than forty years! A day came when there was no longer a choice! Having surrendered will and life to Alcoholism and Addiction, my life was in total desperation! There had to be more to my existence! I bottomed out! There was only up!

But how would I get there? What a puzzle and mystery? A beloved member of A.A., may God's grace and mercy be upon his soul, George H., persistently invited me to a meeting! Cleverly, he suggested I turn out to support the numbers required to keep the meeting alive in the prison! This proved to be a giant step in the right direction! I like many others was raised to believe in a punishing GOD! One who condemns souls to hell because of sin! I willingly removed the cotton from my ears placing it into my mouth. I took all the suggestions! Most important I heard "Find a God of my understanding and religion was not a requirement." Slowly, a door opened!

Reflecting over the last eleven years of growing up, I pieced together the God of my understanding from the fellowship! I admit that I plagiarized the thoughts and ideas of others! I faked it until making it! Little did I understand the meeting was a higher power in itself! I gained inspirations, motivations, clarifications, and identification with folks like myself! I was at home! It was there that I defined Allah in my life! I discovered Spirituality! It was suggested to try living by spiritual principles! With minimum efforts, my investments doubled! A.A. has worked for me just as it's worked for thousands of others! Step Three does not say: "We turned our will and our lives over to the care of God, it says; "We made a DECISION to turn our will and our lives over to the care of God as we understood Him." Only I could make this decision! For the first time in decades a decision was made which paid off bountifully! Alone, I would never succeed!

It was the unconditional love and self-sacrifice from others that is found only in the rooms! There was no compulsion only Tolerance and Patience. My faith developed by witnessing living testimonies.
